POLICY FOR BURNING WITHIN THE HARKER HEIGHTS CITY LIMITS

THIS DEPARTMENT MAY ALLOW CONTROLLED BURNING ON RARE EXTENUATING CIRCUMSTANCES AND WHERE ALL PRACTICAL ALTERNATIVES HAVE BEEN EXHAUSTED AND NO BURN BAN IS IN EFFECT.

- AUTHORITY: Texas Administrative Code, Title 30, Part 1, Chapter 106, subchapter V and Chapter 111, Subchapter B. International Fire Code 2009 Addition, section 307, as adopted by City Ordinance.
- DEFINITIONS: <u>Adequate water supply</u> A supply of water sufficient to extinguish the fire in its entirety, available to the department on-site.

<u>Air Curtain Incinerator (ACI /Trench Burner)</u> – An incinerator, approved by TCEQ, that operates by forcefully projecting a curtain of air across an open chamber or pit in which combustion occurs. Incinerators of this type can be constructed above or below ground and with or without refractory walls and floors.

<u>**Building</u>** - Any structure erected for the support, shelter or enclosure of persons, animals, chattels or property of any kind.</u>

Department - The Harker Heights Fire Department.

Extinguished - The absence of any visible flame, glowing coals or smoke.

Land Clearing Operation - The uprooting, cutting or clearing of vegetation in connection with conversion for the construction of buildings, rights-of-way, residential, commercial or industrial development, or the clearing of vegetation to enhance property value, access or production. It does not include the maintenance burning of on site property wastes such as fallen limbs, branches, or leaves.

1. The person requesting the controlled burn must make application on the form furnished by the Department. The applicant must attach proof, by written bid, that all alternatives (chipping, composting and removal to landfill) have been explored and that those alternatives are not practical.

2. The City of Harker Heights and The Harker Heights Fire Department **requires** the use of Air Curtain Incinerators unless one of the alternative methods above is utilized.

3. The Fire Official or representative shall inspect the proposed burn site, and either grant or disallow the permit based on the conditions as they exist. Burning will only be allowed for the purpose of land clearing. The State of Texas has set the following guidelines that must be followed. These standards are minimum qualifications only. Each request for a burn permit will be handled separately and the Fire Official's decision shall be based on life and property safety, public health and public nuisance considerations. The Fire Official's decision will be final.

4. General Requirements for Allowable Outdoors Burning:

(A). Prior to prescribed or controlled burning for forest management purposes, the Texas Forest Service shall be notified.

(B). Burning must be outside the corporate limits of a city or town except where the incorporated city or town has enacted ordinances which permit burning consistent with the Texas Clean Air Act, Subchapter E, Authority of Local Governments.

(C). Burning shall be commenced and conducted only when wind direction and other meteorological conditions are such that smoke and other pollutants will not cause adverse effects to any public road, landing strip, navigable water, or off-site structure containing sensitive receptor(s).

(D). If at any time the burning causes or may tend to cause smoke to blow onto or across a road or highway, it is the responsibility of the person initiating the burn to post flag-persons on affected roads.

(E). Burning must be conducted downwind of and at least 300 feet (90 meters) from any property not under the ownership of the person making the request and at least 300 feet (90 meters) from any structures regardless of ownership.

(F). Burning shall be conducted in compliance with the following meteorological and timing considerations:

(1). The initiation of burning shall commence no earlier than one hour after sunrise. Burning shall be completed on the same day not later than one hour before sunset, and shall be attended by a reasonable party at all times during the burn phase when fire is progressing. In cases where residual fires and/or smoldering objects continue to emit smoke after this time, such areas shall be extinguished. In no case shall the extent of the burn area be allowed to inverse after this time.

(2). Burning shall not be commenced when surface winds speed is predicted to be less than six miles per hour (mph) (five knots) or greater than 23 mph (20 knots) during the burn period.

(3). Burning shall not be conducted during periods of actual or predicted persistent low-level atmospheric temperature inversions.

(4). There must be a responsible adult on site with the availability of telephonic communications at all times when the material ignited is still burning, to include smoldering ashes.

(G). Electrical insulation, treated lumber, plastics, non-wood construction/demolition materials, heavy oils, asphalt materials, potentially explosive materials, chemical wastes, and items containing natural or synthetic rubber must not be burned.

- 5. Air Curtain Incinerator Requirements.
 - (A) The Texas Commission on Environmental Quality issues permits for the operation of an Air Curtain Incinerator under the Texas Administrative Code Rule **§106.496**.
 - (B) The ACI must be equipped with a run time meter and it must be clearly and permanently marked with the regulated entity (preferred) or account identification number on the fan manifold or aboveground unit.
 - (C) TCEQ must be notified in writing using the Regional Standard Permit/Permit by Rule Relocation Form, include a return receipt, and be received by the regional director and any local air pollution control agency having jurisdiction over the site at least 14 calendar days prior to locating at the site.
 - (D) The length of the trench must not exceed the length of the air blower manifold.
 - (E) The walls of the trench must be maintained such that they remain sufficiently vertical to maintain the air curtain.

- (F) Materials must not be added to the ACI in such a manner as to be stacked above the air curtain.
- (G) An operator shall remain with the ACI at all times when it is operating.
- (H) The adding of materials to the pit must cease early enough and the blower must remain on at the end of the daily burning to ensure enough material is consumed so that any remaining material in the trench does not flame or cause smoke that would be of concern to surrounding areas when the blower is turned off.
- (I) Material being worked and/or stockpiled to be burned later must be kept at least 50 feet from the trench or fire box.
- (J) Should adverse weather conditions result in excessive smoke build-up or impact adjacent occupied properties, the operator shall immediately suspend operations for the duration of the conditions.
- (K) Should mechanical failure interrupt the air curtain in any way, the charging of the pit shall be immediately suspended until the air curtain is operational.
- (L) Upon removal of the ACI from the burn site, ash may be left in the trench and the trench must be completely filled with incombustible material and covered with soil.
- 6. Responsibility for Consequences of Outdoors Burning.

The authority to conduct outdoor burning under this regulation does not exempt or excuse any person responsible from the consequences, damages, or injuries resulting from the burning and does not exempt or excuse anyone from complying with all other applicable laws or ordinances, regulations, and orders of governmental entities having jurisdiction, even though the burning is otherwise conducted in compliance with this regulation.
