

1. Council discussed and considered approving the minutes of the meeting held on January 26, 2021. Fountain made the motion to approve. Seconded by Blomquist. All in favor. Motion passed 5-0.

Presentations by Citizens:

Phillip Sueoka, 200 East Robin Lane, Harker Heights, Texas, presented information regarding issues at his carwash located at 806 South Ann Blvd, Harker Heights, Texas.

New Business:

- 1. Council did not discuss and consider approving a request for a Concept Plan referred to as the Morstatter Subdivision, on property described as Meadow Acres, Block Five (5), Lot Nine (9), McDonald's Mobile Home Park, generally located at 205 W. Beeline Lane, Harker Heights, Bell County, Texas. This item was withdrawn by requestor. No action taken.
- 2. Council discussed and considered approving a request for a Preliminary Plat referred to as the Magill Property, on property described as 3.731 acres of land situated in the Lucy D. O'Dell Survey, Abstract No. 644, and the H.R. Morrell Survey, Abstract No. 579, being a portion of the remainder of a Called 490.1 acre tract conveyed to James Dennis Magill, in Volume 1177, Page 145, Deed Records of Bell County, Texas, generally located within the 3000 Block of Stillhouse Lake Road, Harker Heights, Bell County, Texas. Kristina Ramirez, Planning and Development Director made the presentation. Motion to disapprove passed 5-0.
- 3. Kristina Ramirez, Planning and Development Director made the presentation. McCann made the motion to approve Option #2 for the City of Harker Heights on the Hill Country Transit District Study. Seconded by Fountain. All in favor. Motion passed 5-0.

- 4. DISCUSS AND CONSIDER APPROVING AN ORDINANCE OF THE CITY OF HARKER HEIGHTS, TEXAS, AMENDING ORDINANCE 2020-06 OF THE HARKER HEIGHTS CODE TO EXTEND THE COVID-19 PUBLIC HEALTH EMERGENCY DECLARATION THROUGH APRIL 2, 2021, AND TAKE THE APPROPRIATE ACTION.

EXPLANATION:

The State of Texas and Bell County both have issued disaster declarations that cover Harker Heights in relation to the COVID-19 pandemic. According to the Texas Municipal League (TML) guidance on receiving reimbursements in relation to COVID-19 expenditures, Mayor Smith issued a disaster declaration for the City of Harker Heights on March 20, 2020.

The City Council approved an Ordinance during a special called meeting on April 7, 2020, to extend the Public Health Emergency Declaration to April 30, 2020.

On April 28, 2020, the Council approved an extension to the Public Health Emergency Declaration until May 31, 2020.

On May 26, 2020, the Council approved an extension to the Public Health Emergency Declaration until June 30, 2020.

On June 23, 2020, the Council approved an extension to the Public Health Emergency Declaration until July 31st, 2020.

On July 28, 2020, the Council approved an extension to the Public Health Emergency Declaration until August 31, 2020.

On August 25, 2020, the Council approved an extension to the Public Health Emergency Declaration until September 30, 2020.

On September 22, 2020, the Council approved an extension to the Public Health Emergency Declaration until October 31, 2020.

On October 27, 2020, the Council approved an extension to the Public Health Emergency Declaration until January 31, 2021.

On January 26, 2021, the Council met again and approved another extension to the Public Health Emergency Declaration until March 2, 2021.

Action is now needed again by the Council to consider extending this declaration to match recent directives from the State and Bell County out to <u>April 2, 2021</u>.

This declaration continues to align with the City's COVID-19 response measures to those issued by Bell County and the State. If Bell County or the State modify their orders, then the City's requirements would automatically reflect these modifications, to include the Governor's staged initiatives of "Reopening Texas".

The Council may at any time choose to end, modify, and/or extend the declaration.

STAFF RECOMMENDATION:

Staff recommends approval of the extension.

ACTION BY CITY COUNCIL:

- 1. Motion to APPROVE/DISAPPROVE an Ordinance amending Ordinance 2020-06 of the Harker Heights Code to extend the COVID-19 Public Health Emergency Declaration through April 2, 2021.

AN ORDINANCE OF THE CITY OF HARKER HEIGHTS, TEXAS, AMENDING ORDINANCE 2020-06 OF THE HARKER HEIGHTS CODE TO EXTEND THE COVID-19 PUBLIC HEALTH EMERGENCY DECLARATION THROUGH APRIL 2, 2021.

WHEREAS, the City Council ("Council") of the City of Harker Heights ("City") finds that it is necessary and desirable to amend the Code of Harker Heights ("Code") as hereinafter provided in order to extend the Public Health Emergency Declaration; and

WHEREAS, the meeting at which this Ordinance was passed was open to the public, and notice of the time, place and purpose of said meeting was given as required by law, all in strict accordance with the requirements of the Texas Open Meetings Act;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HARKER HEIGHTS, TEXAS:

SECTION 1: The City Council officially finds and declares that the facts and recitations set forth in the preamble to this ordinance are true and correct.

SECTION 2: Ordinance 2020-06, 2, of the Code of Harker Heights is hereby appended with the following:

2. This declaration ratifies the disaster declaration issued by Harker Heights Mayor Spencer H. Smith on March 20, 2020, and this declaration shall run until April 2, 2021.

SECTION 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are to the extent of such conflict hereby repealed.

SECTION 4: This ordinance shall be effective from and after its passage, and the City Secretary shall publish the caption or title of hereof within ten days as required by law.

FROM: THE OFFICE OF THE CITY MANAGER DATE: FEBRUARY 23, 2021

DISCUSS AND CONSIDER APPROVING AN ORDINANCE OF THE CITY OF HARKER HEIGHTS, TEXAS, AFFIRMING AND EXTENDING THE MAYOR'S DECLARATION OF DISASTER DUE TO SEVERE WINTER WEATHER ISSUED ON FEBRUARY 16, 2021, AND TAKE THE APPROPRIATE ACTION.

EXPLANATION:

On February 12, 2021, Texas Governor Greg Abbott certified that a severe winter storm posed an imminent threat of widespread and sever property damage, injury, and loss of life due to prolonged freezing temperatures, snow, freezing rain, and ice. Governor Abbot further declared a state of disaster for all 254 counties in the State of Texas. Bell County Judge David Blackburn declared a state of emergency in the County and announced the closure of non-essential county offices on February 15, 2021.

The City of Harker Heights, along with the entire region, has iced-over roads, and loss of electric, gas, telephone and water utility services caused by extreme winter weather and freezing conditions presenting a threat of widespread or severe damage, injury, or loss of life and property.

Under the authority granted to the Mayor of Harker Heights, Spencer H. Smith declared a state of disaster on February 16, 2021, for the City of Harker Heights. The Declaration implements the City's Emergency Management Plan in which the City can acquire all resources needed to protect life and property for the winter weather.

The Council must take action at the next Council meeting after a disaster declaration is made by the Mayor to affirm and extend the declaration.

RECOMMENDATION:

Staff recommends approval of the extension.

ACTION BY CITY COUNCIL:

- 1. Motion to APPROVE/DISAPPROVE an Ordinance of the City of Harker Heights, Texas, declaring a public health emergency due to severe winter weather; Providing that the declaration extends through March 23, 2021; Authorizing the City to provide aid and assistance; Allow the waiver of permitting fees for repair damage directly related to the winter storms; And providing for an effective date.

MAYOR'S DECLARATION OF LOCAL STATE OF DISASTER DUE TO SEVERE WINTER WEATHER

WHEREAS, on February 12, 2021, Texas Governor Greg Abbott certified that a severe winter weather poses an imminent threat of widespread and severe property damage, injury, and loss of life due to prolonged freezing temperatures, snow, freezing rain, and ice; and

WHEREAS, Governor Abbott has declared a state of disaster for all 254 counties in the State of Texas; and

WHEREAS, on February 15, 2021, Bell County Judge David Blackburn declared a state of emergency in the county and announced the closure of non-essential county offices; and

WHEREAS, iced-over roads, and loss of electric, gas, telephone and water utility services caused by extreme winter weather and freezing conditions present an imminent threat of widespread or severe damage, injury, or loss of life and property resulting from extreme winter weather conditions and other public calamity resulting there from, which requires emergency action; and

WHEREAS, the Mayor of the City of Harker Heights has determined that extraordinary measures must be taken to prevent and to alleviate the suffering of people and to protect or rehabilitate property; and

WHEREAS, said state of disaster requires that certain emergency measures be taken pursuant to Chapter 418 of the Texas Government Code.

NOW THEREFORE, I, MAYOR OF THE CITY OF HARKER HEIGHTS, PURSUANT TO THE AUTHORITY VESTED BY TEXAS GOVERNMENT CODE CHAPTER 418, HEREBY FIND, DECLARE AND ORDER:

SECTION 1. That pursuant to Section 418.108(a) of the Texas Government Code and the authority it vests in the Mayor, a local state of disaster caused by the winter weather emergency, as declared and certified by the Governor of the State of Texas, is hereby declared for the City of Harker Heights, Texas.

SECTION 2. That pursuant to Section 418.108(b) of the Texas Government Code, this local state of disaster prompted by the winter weather emergency shall continue for a period of not more than seven (7) days from the date of this declaration unless continued or renewed by the City Council of the City of Harker Heights.

<u>SECTION 3.</u> That pursuant to Section 418.108(c) of the Texas Government Code this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the City Secretary.

SECTION 4. That pursuant to Section 418.108(d) of the Texas Government Code, this declaration of a local state of disaster activates the Harker Heights, Texas, emergency management

plan.

- **WHEREAS,** on February 12, 2021, Texas Governor Greg Abbott certified that a severe winter weather poses an imminent threat of widespread and severe property damage, injury, and loss of life due to prolonged freezing temperatures, snow, freezing rain, and ice; and
- **WHEREAS,** Governor Abbott has declared a state of disaster for all 254 counties in the State of Texas; and
- **WHEREAS,** on February 15, 2021, Bell County Judge David Blackburn declared a state of emergency in the county and announced the closure of non-essential county offices; and

- **WHEREAS,** on February 16, 2021, Harker Heights Mayor Spencer H. Smith declared a Local State of Disaster for the City of Harker Heights; and
- **WHEREAS,** on February 19, 2021, President Joseph R. Biden, Jr. declared that a major disaster exists in the State of Texas and ordered federal assistance to supplement state and local recovery efforts in the areas affected by severe winter storms beginning on February 11, 2021, and continuing; and
- **WHEREAS**, the declaration of a state of disaster facilitates and expedites the use and deployment of resources to enhance preparedness and response; and
- **WHEREAS**, the declaration of a state of disaster includes the ability to take measures to promote the public health, safety and welfare; and
- **WHEREAS**, the City Council finds that it is in the public interest to waive permitting fees directly related to damage repair in result to the winter storms; and
- **WHEREAS**, the meeting at which this ordinance was passed was open to the public, and notice of the time, place and purpose of said meeting was given as required by law, all in strict accordance with the requirements of the Texas Open Meetings Act.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HARKER HEIGHTS, TEXAS, AS FOLLOWS:

- 1. That a local state of disaster for public health emergency is hereby declared for the City of Harker Heights, Texas, pursuant to section 418.108(a) of the Texas Government Code.
- 2. This declaration ratifies the disaster declaration issued by Harker Heights Mayor Spencer H. Smith on February 16, 2021, and this declaration shall run until March 23, 2021.
- 3. That pursuant to section 418.108(c) of the Government Code, this declaration of a local disaster for public health emergency shall be given prompt and general publicity and shall be filed promptly with the City Secretary.
- 4. That pursuant to section 418.108(d) of the Government Code, this declaration of a local state of disaster activates the City of Harker Heights emergency management plan and authorizes the furnishing of aid and assistance under this declaration.
- 5. That this declaration shall take effect immediately from and after its issuance, and upon approval of the City Council, shall continue in effect until terminated by the Mayor. Pursuant to this declaration, additional directives may be issued by the Mayor at any time as deemed necessary.
- 6. The City of Harker Heights, acting through its governing body, hereby confirm and approve waiving permitting fees to repair damage as a direct result of the winter storms.
- 7. The permitting fee waiver expires March 23, 2021.

DISCUSS AND CONSIDER APPROVING AN APPEAL OF THE FALSE ROBBERY ALARM SERVICE CHARGE ON MARY A. BIANCO AT 2026 HERALD DRIVE, HARKER HEIGHTS, TEXAS, AND TAKE THE APPROPRIATE ACTION.

EXPLANATION:

Section 99.08 of the City's Code of Ordinances grants an appeal process for false alarm charges. Appeals to false alarm charges must be made within 14 days of being given notice of a false alarm charge. By Code, the City Manager is the Alarm Administrator and issues the notice of false alarm charge and the City Council is the body that hears any appeals of the charge.

Officer Justin Smith with the City of Harker Heights responded to a robbery alarm at the home of Ms. Mary A. Bianco, 2026 Herald Drive, Harker Heights, Texas, on December 18, 2020, at 8:14 p.m. No evidence of robbery was found. Accordingly, per §99.06 of the Code of Harker Heights and the City's fee schedule, Ms. Bianco was assessed a false alarm service charge of \$75.00. The City mailed a letter to Ms. Bianco informing her of the fee on January 19, 2021.

On February 4, 2021, the City received a letter from Ms. Bianco appealing the Service Charge Assessment. On February 8, 2021, staff spoke with Ms. Bianco by telephone to explain the process and notify her of the date and time of her appeal hearing. On Wednesday, February 10, 2021, a confirmation notice was sent to Ms. Bianco notifying her of the date and time that her appeal would be heard before the City Council.

Section 99.06 of the Harker Heights Code of Ordinances provides the following provisions about false alarm charges:

- (A) If, within any 12-month period occurring after the effective date of this chapter, five false burglar alarm notifications are made from an alarm site, the Alarm Administrator shall assess the alarm user at that alarm site a fee for each subsequent false burglar alarm notification made from the site during the 12-month period.
- (B) The Alarm Administrator shall assess an alarm user for each false robbery alarm notification emitted from the alarm site.
- (C) If, within any 12-month period occurring after the effective date of this chapter, two false fire alarm notifications are made from an alarm site, the Alarm Administrator shall assess the alarm

user at that alarm site a fee for each subsequent false fire alarm notification emitted from the site during the 12-month period.

- (D) If, within any 12-month period occurring after the effective date of this chapter, two false emergency medical assistance alarm notifications are made from an alarm site, the Alarm Administrator shall assess the alarm user at that alarm site a fee for each subsequent false emergency medical assistance alarm notification made from the site during the 12-month period.
- (E) The Alarm Administrator shall send written notice to the alarm user of any fee assessed under this chapter. The notice shall be hand delivered to the alarm user, or sent by certified mail, return receipt requested, to the alarm user at the alarm user's last known address.
- (F) An alarm user shall pay any fee assessed under this chapter within 30 days after the date the fee is assessed.
- (G) No fee shall be assessed pursuant to this section, if:
 - (1) The alarm notification is cancelled prior to city personnel arriving at the alarm site; or
 - (2) The alarm is shown by the alarm user to have been, in the Alarm Administrator's sole determination, justified, or due to a natural or man-made catastrophe or other situation specifically exempted by the Alarm Administrator.

Robbery false alarms require a fee to be charged on the first occurrence due to the severity/priority that these calls get. Ms. Bianco's letter states the following:

"I recently purchased the home at the beginning of November and learned that there was an alarm system at the house. I had contacted Vivint, the alarm company, and told them I did not need the alarm system, and to cancel it. They advised me that it would be cancelled at the end of the month.

Unbeknownst to me, the alarm system was still owned by the former owner of the house. She had not disconnected it or cancelled her account with the monitoring company, Vivint.

Apparently, on December 18, the former owner somehow setoff the alarm from her mobile phone, and I had no idea that an alarm had been triggered. Of course, when she activated the alarm, the police were dispatched. I was not home at the time, and my son, who was there, had no knowledge about the alarm system in the new house, since we did not have an account or a "PIN" Number, code, or other control over the system. He explained the situation to the police when they arrived."

While this certainly may be the case, the Police Department must still respond quickly to the location to ensure that the person cancelling the alarm is not under duress.

The City's letter to citizens/businesses that have false alarms strongly encourages that the alarm system be property adjusted, operated, inspected, and or service to avoid future false alarms, service charges, and possible termination of alarm response.

STAFF RECOMMENDATION:

Staff recommends dismissing the service charge.

Under \$99.08 of the Code you have the right to appeal this service charge assessment by filing a written request for a hearing with the City Secretary within 14 days after this notice was mailed, setting forth the reasons for the appeal. The City Secretary will then set a hearing before the City Council, and you will be notified of the date and time of that hearing so you can appear in person and present your case. If you do not appeal, payment of the service charge is due within 30 days after the date of this letter.

Please note that police and fire responses to alarm notifications may be terminated if your system is determined to be unreliable, or if a false alarm service charge is not paid. Accordingly, we strongly urge you to ensure that your system is properly adjusted, operated, inspected, and serviced in order to avoid future false alarms, service charges, and possible termination of alarm response.

BACKGROUND:

The Atmos Cities Steering Committee ("ACSC") is composed of 178 municipalities in the service area of Atmos Energy Corporation, Mid-Tex Division ("Atmos") that have retained original jurisdiction over gas utility rates and services within municipal limits. Because Atmos has no competitors, is a monopoly provide of natural gas, regulation of the rates that it charges its customers is the only way that cities can ensure that natural gas rates are fair.

ACSC is the largest coalition of cities served by Atmos and by working as a coalition to review the rates charged by Atmos cities are able to accomplish more collectively than they would by acting alone. The 178 members of ACSC currently represents 60 percent of the total load served by Atmos. ACSC protects the authority of municipalities and defends the interests of residential and small commercial customers within the cities.

The rate cases that ACSC actively participates in are typically reimbursed by the utility however, ACSC is also involved in appeals, rulemakings, and legislative efforts impacting the rates charged by Atmos within the City. There is always a possibility that additional efforts will be necessary on new issues that arise during the year, and it is important that ACSC be able to fund its participation.

A per capita assessment has historically been used by ACSC to fund its participation on behalf of its member cities. The total due from the City of Harker Heights is \$1,550 which is the 2021 per capita fee of 5 cents times the Harker Heights population figure found in the Texas Municipal League Directory of City Officials of 31,000.

RECOMMENDATION:

Staff recommends approving the Resolution.
