DISCUSS AND CONSIDER APPROVING A RESOLUTION OF THE CITY OF HARKER HEIGHTS EMPLOYEE BENEFITS TRUST AWARDING CONTRACTS FOR THE CITY OF HARKER HEIGHTS EMPLOYEE BENEFITS TRUST GROUP MEDICAL PLAN, VISION BENEFITS, DENTAL BENEFITS, LIFE INSURANCE, AD&D AND LONG TERM DISABILITY AND AUTHORIZING THE CITY MANAGER TO ENTER INTO SUCH CONTRACTS ON BEHALF OF THE CITY AND THE EMPLOYEE BENEFITS TRUST, AND TAKE THE APPROPRIATE ACTION.

## **EXPLANATION:**

The City has a need for employee health insurance, vision benefits, dental benefits, life insurance, AD&D, and long term disability. The City held negotiations with the current providers for best and final proposals, with Scott and White Health proposing a 9.0% increase above current rate. Current providers for vision and life insurance and AD&D remained at the same rate as FY 2020-2021. The current provider for dental benefits, Lincoln Financial, decreased by 1.1% from FY 2020-2021 rates.

### **RECOMMENDATION:**

The Director Human Resources recommends approving a resolution awarding contract renewals to the following:

- 1. Medical Benefits Scott and White Health Plan BSW Preferred and BSW Plus (which uses a broader HMO network)
- 2. Vision Benefits Superior Vision for Gold Plan 75
- 3. Dental Benefits Lincoln DentalConnect
- 4. Life and AD&D Benefits Lincoln Financial
- 5. Long Term Disability (LTD) Lincoln Financial using the Premier Plan

- 5. The Trust hereby officially finds and determines that the meeting at which this resolution was passed was open to the public, and that notice of the time, place

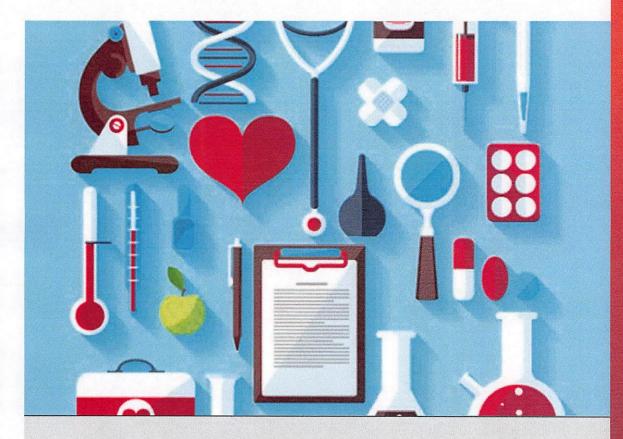

# **Medical Coverage**

- Last year, the current provider Scott and White Health Plan guaranteed a 9.9% rate cap for 2021/2022.
- The medical loss ratio for 2020/2021 is trending at 107.06% due to several large claims and several high-cost maintenance drugs.
- Plan experience requires an increase of +13.6% which does not take into account demographic changes; when taking that into account Scott and White's formula calls for a +24.19% increase.
- After the City held negotiations, Scott and White Health Plan offered a renewal increase of 9% for current plans.

# **EXPLANATION:**

The City of Harker Heights Employee Benefits Trust declares that the City holds in trust the funds and all substitutions and additions to such funds, for the purpose of providing life, disability, and other health benefits to the City's employees and qualified retirees and their dependents. The assets previously transferred to the Trust for the purpose of providing such benefits have been expended, and must be replenished in order to fund the continuation of those benefits.

- 4. All actions taken or performed by David Mitchell and Ayesha Leaiilee prior to the date hereof in respect to the matters referred to and approved in this resolution be and hereby are ratified and confirmed in all respects.
- 5. ### The conditions are:

- 1. Dedication of additional public right-of-way for Gnome Drive and Lago Vista Drive is not required with this platting action.
- 2. Provide the required sidewalks in the subdivision design.
- 3. Provide connectivity of the 20' off site access easement that enters into Lot 75, Block 1 to the proposed sidewalks and the U.S.A. property.
- 4. All comments from Clearwater Underground Water Conservation District shall be adequately addressed and resolved with City Staff approval prior to approval of the final plat.
- 5. All comments from Bell County shall be adequately addressed <u>and resolved with City Staff approval</u> prior to approval of the final plat.
- 6. All comments from Dog Ridge Water Supply Corporation shall be adequately addressed <u>and resolved</u> <u>with City Staff approval</u> prior to approval of the final plat.

#### CONDUCT A PUBLIC HEARING TO DISCUSS AND CONSIDER APPROVING AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HARKER HEIGHTS, TEXAS, AMENDING THE FISCAL YEAR 2020-2021 GENERAL FUND, UTILITY FUND, AND FIXED ASSET FUND BUDGETS, AND TAKE THE APPROPRIATE ACTION.

#### BACKGROUND:

On September 8, 2020, the City Council voted to approve the Fiscal Year 2020-2021 Budget which started on October 1, 2020 and will end on September 30, 2021. This budget amendment addresses the need to reflect federal funds received / expected to be received during the fiscal year and the use of those funds during the current fiscal year as follows:

- (1) Grant Revenue: Following are major grant revenue received or expected to be received during the current fiscal year:
  - a. On April 22, 2021, the City received the remaining Coronavirus Relief Funds (CRF) in the amount of \$371,995. The total amount awarded was \$1,789,370 of which \$1,417,375 was recognized in FY 2020.
  - b. The American Rescue Plan Act of 2021 (ARPA) provides for \$19.53 billion to be distributed to Non-Entitlement Units (NEUs) from their respective States. Based on the formula provided, the City of Harker Heights will receive approximately \$8,033,468 in two tranches; the first of which is expected in FY 2021. The second tranche will be no earlier than one year of receipt of the first payment. NEUs must first wait for their State to request and receive the funds from the U.S. Treasury after which they can apply for two 30-day extensions to distribute funds.
- (2) Staff has seen the need for security cameras at various city facilities and proposes the use of these grant funds to purchase these in the current fiscal year.
  - a. CRF funds in the amount of \$212,700 would be allocated to this project to cover the General Fund expenses. These funds have already been earned by the City and were a reimbursement. There are no restrictions placed on the use of these funds. The departmental expense will be shown under the Information Technology Department.
  - b. ARPA funds in the amount of \$146,600 would be allocated to cover the Utility Fund expenses. These funds have restrictions on their use, one of which is for water and sewer infrastructure to include adding security measures. The departmental expense will be shown under the Water Operations Department.

**NOTE 1:** Departmental fixed asset expenses are reimbursed by the Fixed Asset Fund, therefore the General and Utility Fund's total expenses / expenditures are not affected by the addition of the security camera purchases.

**NOTE 2:** There are other items that Staff would like for the City Council to consider to be funded from these two sources for the 2022 fiscal year and those will be brought before you at a future meeting.

(3) Expenses for the Water Operations Department in the Utility Fund would increase by \$146,600 due to the increase in fixed asset purchases.

**NOTE 1:** Departmental fixed asset expenses are reimbursed by the Fixed Asset Fund, therefore the General and Utility Fund's total expenses / expenditures are not affected by the addition of the security camera purchases.

- (4) Additional revenue would be added as a transfer into the Fixed Asset Fund \$212,700 from CRF and \$146,600 from ARPA.
- (5) A fixed asset purchase expense of \$359,300 would be added to the budgeted expenses in the Fixed Asset Fund bringing the budgeted purchases total to \$1,376,100.

WHEREAS, the public hearing on the proposed amended budget was held in accordance with the published notices; and

WHEREAS, it is the desire of the City Council of the City of Harker Heights to amend the budget.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Harker Heights, Texas:

**SECTION 1:** That the City Council amends the 2021 fiscal year budget by adopting the amendments attached as "Exhibit A".

**SECTION 2:** That all other portions of the existing 2021 fiscal year budget, except herein amended, shall remain in full force and effect, and not otherwise be affected by the adoption of this ordinance.
