The purpose of the Greater Killeen Community Clinic is to provide quality healthcare to vulnerable populations, to include both adults and children who are uninsured and underserved.

Acute Care- 3 times a week for minor illnesses to include fever, colds, sprains, etc.

Chronic Care- 3 times a week for patients with chronic diseases (diabetes, COPD, etc.)

Behavioral Health- 2 times a week via telehealth by appt. only with psych resident

Cardiology- once a month to patients with heart concerns/issues

Bell County Indigent Program- 4 times a week for patients who can't receive any medical support PAP- prescription assistance program where we assist chronic patients in receiving free medications, primarily insulin

Food Box distribution- done monthly for patients and their families

Lunch n Learn- educational classes provided once a month for patients and their families to receive resourceful information to help improve their health and habits

Funds will be used to provide medication(s)/prescription(s) to patients at no out of pocket cost. Patients are able to receive medication at the local H-E-B pharmacy where they present prescription, as prescribed by providers from the Greater Killeen Community Clinic.

What is the primary purpose for the use of funds?

The primary purpose for the use of funds will be to provide medication(s)/prescription(s) to patients that are seen at the Clinic and are residents of Harker Heights free of cost to them, with no out of pocket expense.

How does the use of the funds enhance the quality of life in the City of Harker Heights?

The Greater Killeen Community Clinic has seen an increase in patients since the pandemic hit in 2020. The Clinic is able to fill the gap in providing quality healthcare services to patients who are uninsured and reside in the City of Harker Heights at a very minimal cost to them, while receiving costly medical care to them to get them back to optimal health and by providing them with a consistent primary care provider.

Economic Impact

How does the organization expect to use other Harker Heights businesses while carrying out the proposed use of the requested funds?

The Clinic has created the Heart of Heights Clinic to provide acute care to residents of Harker Heights after hours. We have used the Harker Heights Activities Center and plan to continue to do so throughout the year, with quarterly Clinics. We also are continuing to work with Seton Medical Center Harker Heights and Harker Heights Lions Club through services and volunteer, as well as staff.

Will the proposed use of funds necessitate additional workers whether volunteer or paid? Please describe.

The proposed use of funds will not require additional paid staff or volunteers. However, we do continue to work with our health care partners and local student nursing programs to create volunteer space at the Clinic, with community outreach and projects we engage in.

The Greater Killeen Community Clinic has been in existence for the past 27+ years. The plan is to continue the Work of the Clinic by being mission focused and taking care of each and every patient we touch, encounter and engage with.

Provide the purpose of the organization.

VARIETY of TEXAS is a charitable organization that opens up the world for kids with special needs, and their families, by providing resources and empowering experiences. We envision a world without isolation and stigma for children with special needs and their families.

PEACEABLE KINGDOM, by VARIETY, located near Harker Heights, TX is a beloved safe haven for thousands of children exploring their self-reliance, mobility, independence and friendships. In support of our mission of healing through nature, we've tailored our 122-acres to accommodate all needs. Peaceable Kingdom has become a place where kids of all abilities can push their personal limits while they discover the empowering freedom that comes from the great outdoors.

List current programs the organization operates with a brief description of each.

Summer Camp - Partnering with Texas-based nonprofits, hospitals and schools, we offer diagnosisspecific summer camps to children affected by cancer, diabetes, asthma, missing limbs, arthrogryposis, deaf/blindness, juvenile arthritis, neurological differences, intellectual differences and grief. We host two camps for adults affected by intellectual differences and those who are deaf and blind. We are excited to add two new camps this summer, both focusing on youth leadership. This program typically serves 600 - 650 youth and adults.

Family Camp - We are excited to launch a new program, Family Camp at Peaceable Kingdom. This program was created for children who may never get to experience a traditional sleep-away camp due to disability or illness. For children who are dependent upon parents and caregivers, this is an opportunity for the entire family to experience summer camp.

Teachable Kingdom - Variety of Texas has developed the customized (and adaptive) Teachable Kingdom curriculum for grades PreK – 12, fully aligned with Texas Essential Knowledge and Skills (TEKS) objectives. The field trip program is designed to complement the classroom and inspire a passion for lifelong learning and growth. Because educational content is delivered through activity, adventure and experiential learning, Teachable Kingdom programming is especially beneficial for a student with special needs or an individual education plan (IEP).

TK Transitions – In partnership with local school districts, our team at Peaceable Kingdom has dentified a need for increased attention on students receiving special education services as they transition out of the school setting and into independent living. To respond to that need, Variety of Texas has developed *Teachable Kingdom: Transitions*, a host of events and activities that promote developmentally appropriate opportunities for learning job skills and social emotional skills.

Heart of Variety – Lead by committee, this program provides significant financial assistance to families who have a child/children with special needs. When insurance or Medicaid deems something medically unnecessary, families can apply to this program for assistance. We typically provide up to \$350,000 in financial assistance per year.

Variety's iCanShine Bike Camp - In collaboration with local Parks and Rec Departments, Variety Bike Camp teaches children with special needs to ride traditional 2-wheeled bicycles. After a week of camp, 90% of the children attending bike camp find the joy and freedom of two-wheels.

Funds from the City of Harker Heights would be used to launch the Peaceable Kingdom To You (PK2U) program benefiting the residents of Harker Heights who live with special needs, their families and their peers. Forty seven percent of the funds will support salaries and benefits for each employee contributing to the program. Fifty three percent of the funds will directly support the program. Funding of \$25,000 is approximately 2% of our annual budget. As such, allocations below reflect that 2%.

Net Income

What is the primary purpose for the use of funds?

If awarded, the funds will be used launch Variety of Texas's newest program, Peaceable Kingdom to You (PK2U). Developed prior to the devastation of COVID, PK2U was created to expand Variety's programming into the communities that surround our summer camp and retreat center. The purpose of the program is to provide social and adapted recreational activities and events for those living with special needs and their families. The beauty of the program is that we can adapt to the needs of the Harker Heights community.

The core of the program will revolve around adapted archery at Peaceable Kingdom, as well as mobile archery events and instruction in Harker Heights. Preliminary discussions with Jeff Achee, Director of Harker Height Parks and Recreation and Joe Flores, JROTC Instructor at Harker Heights High School suggest a strong collaboration will be formed to promote to the community, as well as solidify locations for the community archery events.

While the core of the program will revolve around adapted archery, the beauty of the program is that we can quickly adapt to include other activities or events desired by the community.

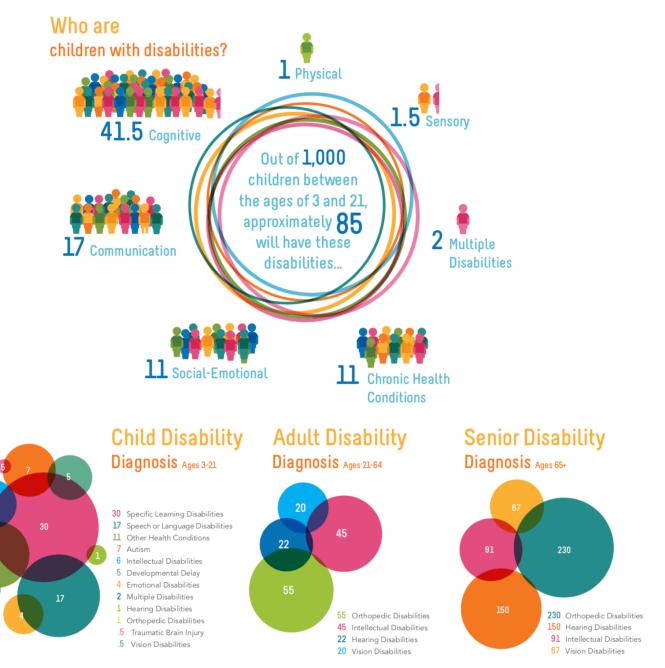
Proposed components of the program include, but are not limited to:

- Monthly adapted archery event at Peaceable Kingdom, offered only to the residents of Harker Heights.
- Quarterly adapted archery events in the Harker Heights community, ideally in collaboration with Harker Heights Parks and Recreation Department and Harker Heights High School JROTC
- Biannual Harker Heights "Day of Play" at Peaceable Kingdom open to all Harker Heights residents with a focus on those living with special needs.

How does the use of the funds enhance the quality of life in the City of Harker Heights?

Research supports the need for inclusive programming that bring more meaningful play and social experiences to more people, to the greatest extent possible. Statistics show the following: *

- Out of 1000 children between the ages of 3 and 21, approximately 85 will have a disability.
- Out of 1000 adults between the ages of 21 and 64, approximately 142 will have a disability.
- Out of 1000 seniors 65+, approximately 538 will have a disability.



Each year, Variety serves nearly 7000 children with special needs through our existing programs. That's thousands of kids with physical and cognitive differences and chronic illnesses. But it's also thousands of kids who are so much more than the challenges they face. With support from the City of Harker Heights, our impact can extend beyond the walls of Peaceable Kingdom and into the Harker Heights community. We can also extend our impactful programming beyond the child with special needs by welcoming their families and peers to participate. Finally, we are excited to welcome adults living with special needs to experience our adapted programs. 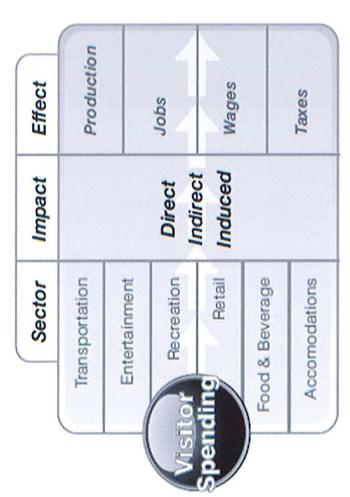

Sign Locations		
State and federal laws limit where these types of civic organization signs can be placed. Signs are primarily designed for non-controlled access highways such as US or State highways, Farm and Ranch to Market roads, spurs and loops.		
City Pride Signs are located along highway entrances to the city and are placed 300 to 800 feet from		
existing city limit signs. A sign may be placed on each highway entering the city. For controlled access highways, such as Interstates, signs are placed on the frontage road.

The cost for a City Pride Sign can range from \$100 to \$2,000 depending on the sign's size and design. The maximum size is 80 square feet (10 feet wide by 8 feet high). In addition to the sign designs developed by TxDOT, a city may submit alternate designs as long as the sign meets TxDOT specifications and maintains breakaway capability.
