RECEIVE AND DISCUSS A PRESENTATION BY URYAN NELSON, DIRECTOR OF THE KILLEEN-TEMPLE METROPOLITAN PLANNING ORGANIZATION (KTMPO) REGARDING THE BACKGROUND, PURPOSE AND FUTURE OF THE ORGANIZATION. (ASSISTANT CITY MANAGER)

EXPLANATION:

The Killeen-Temple Metropolitan Planning Organization (KTMPO) is responsible for establishing a comprehensive transportation planning process for the greater area around Killeen and Temple. The KTMPO is comprised of a Transportation Planning Policy Board and a Technical Advisory Committee whose members are community and county elected officials and/or are appointed by those officials.

The KTMPO boundary covers all of Bell County, parts of Coryell and Lampasas counties, portions of Fort Hood and encompasses the following cities: Bartlett, Belton, Copperas Cove, Harker Heights, Holland, Kempner, Killeen, Little River-Academy, Morgan's Point Resort, Nolanville, Rogers, Salado, Temple, and Troy.
