CONTEST RULES & REGULATIONS

I understand that to be eligible for the contest; I must agree to the following as indicated by my signature below:

1. I must return my entry form by drop off, mail, fax, or email no later than 5:00 pm on Friday, December 7, 2018.
2. Wreaths must be handmade and can be made out of any material, i.e. mesh, burlap, conifer greenery, etc. Wreaths should be single faced. They will be judged hanging on a wall or lying on a table.
3. No breakable/glass items are allowed on the wreaths, battery operated lights are permissible.
4. Secure all decorations firmly to the wreath. *Securely attach the top of your wreath a ribbon or wire for proper hanging.*
5. Staff will secure the theme & wreath number to the bottom of your wreath, when it arrives
5. Wreaths may not weigh more than 15lbs or be larger than 32 inches wide or 42 inches long.
6. I must deliver my entry to Frost Fest at Market Heights on Friday, December 14, 2018 between 3:00pm-5:00pm. Specific location of wreath tent will be e-mailed to all entries for drop off.
7. My entry will remain on display during the duration of Frost Fest and be judged together via popular vote.
8. I must pick up my entry after Frost Fest between the hours of 8:30pm and 8:45pm on Friday, December 14, 2018. Entries not picked up by 8:45pm will be discarded.
9. I understand that only one entry per person/group can be entered.
10. Permission is hereby granted to City of Harker Heights to take photos of my entry and/or myself/family or child(ren) with the entry for department use and may be used in future brochures, flyers, presentations, ads, on the City's website and social media. I understand that the image of my entry becomes the property of the City.
11. I understand that at no time does the City of Harker Heights guarantee the safety or security of my entry and cannot be held responsible for any damages incurred to my entry on or off city property.
12. The City of Harker Heights reserves the right to refuse entries that are deemed inappropriate for display at Frost Fest, to disqualify any competitor who fails to follow the Rules and Regulations contained herein and/or to disqualify any competitor who falsifies any information which is submitted on this entry form.
